(Head office: Naha, Okinawa; President & CEO: Kenji Sugimoto) and Okinawa Cellular Telephone Company (Head office: Naha, Okinawa; Representative Director: Hideo Yuasa).

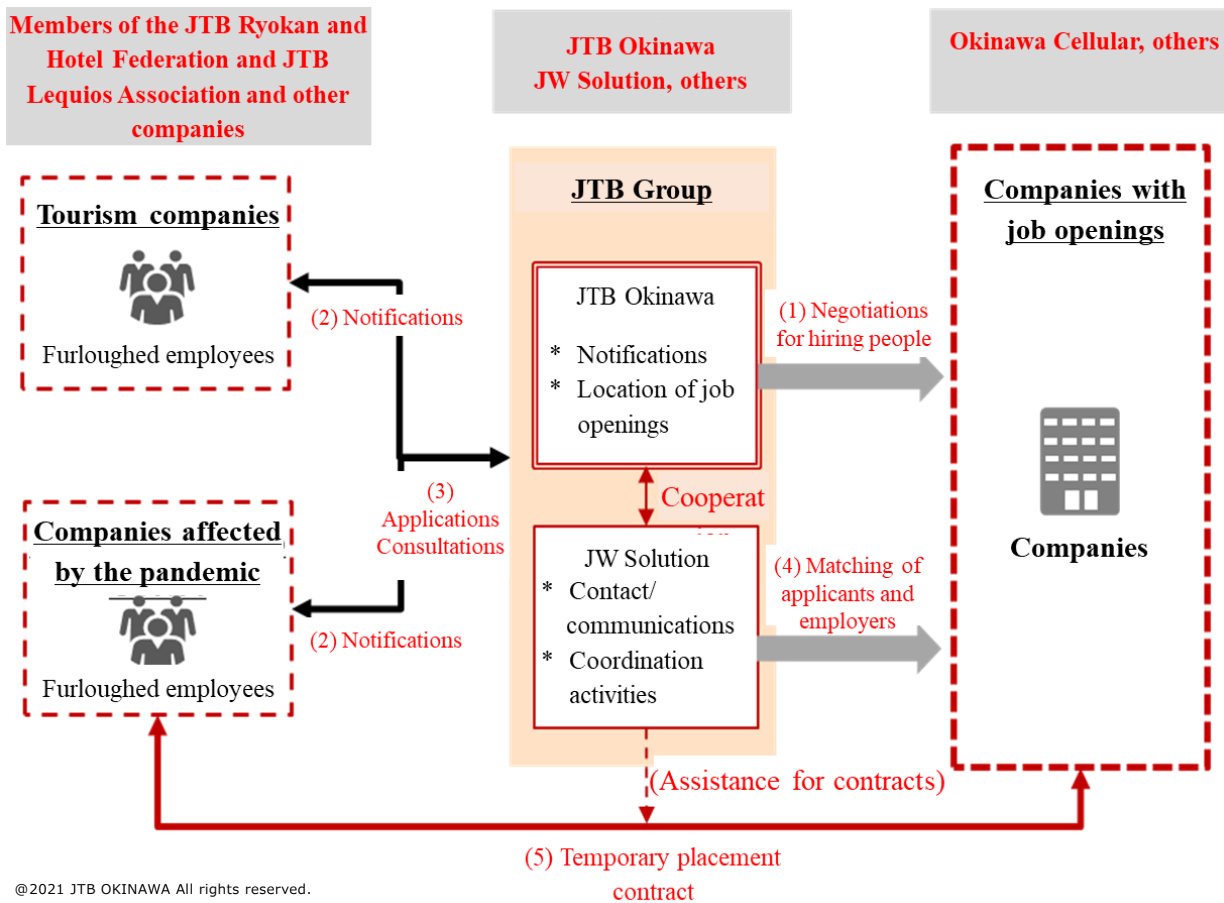
### **Summary**

The COVID-19 pandemic has forced companies in Okinawa prefecture to temporarily reduce or suspend business activities. A human resources sharing program has started for the purpose of preserving jobs and preventing unemployment by matching employees who were furloughed by companies and other organizations, as well as others in need of a job, with companies and industries where there is a labor shortage.

This program uses the Industry Employment Stabilization Subsidy system that was created to preserve jobs by finding temporary positions at other companies and organizations. Individuals retain their status as employees of their original employers. In this program, employees of companies belonging to the JTB Ryokan and Hotel Federation and the JTB Lequios Association are assigned to jobs at Okinawa Cellular and other companies. The matching process is conducted jointly by JTB Okinawa and JWS.

The mission of the World Holdings Group is creating the “ways we live.” Group companies create places that enable large numbers of people to perform jobs that contribute to fulfilling lives. The prolonged COVID-19 crisis is having a severe impact on the economy of Okinawa, particularly the tourism industry. By fully utilizing expertise acquired over many years, the World Holdings Group plans to play a role in supporting the economy of Okinawa as well as to contribute to the growth of the tourism industry, which is an important component of the Japanese economy.
